Important Information regarding the Future Stars Southampton transportation policy:

Future Stars Southampton offers door-to-door transportation from Westhampton to Watermill. Anyone living east of Watermill will be picked up at the Bridgehampton Starbucks. Parents must notify the office at least one (1) week, or seven (7) days, in advance of the week that the camper will be taking the bus. Please note that the office must be notified seven (7) days prior to the start date of the camp week, not necessarily seven (7) days before your camper is starting camp. For example, if you plan on using transportation for the week of Monday, June 19, the office must be notified by Monday, June 12 – even if you do not plan on sending your camper to camp until a later day during that week.*

If you do not request transportation by the seven (7) day in advance deadline, we cannot guarantee that transportation will be available for your camper, however we will always do our best to accommodate.

Any changes to your transportation schedule must be relayed to the main office. For example, if your camper normally takes the bus but is being picked up by a parent/babysitter, if your camper is only taking the bus for select days of the week, if your camper only takes the bus in the mornings, et cetera, **the office must be notified directly.** It is important that the main office be communicated with directly as the main office is in contact with the bus company. Please do not rely on third-parties separate from office management and/or office assistants to relay the information to the main office. This includes counselors.

Transportation runs twice a day – once in the morning for 9:00am drop-off, and once in the afternoon for 4:00pm pick-up. If a camper is in Little Stars, the camper will need to stay for the extended day program until 4:00pm as there is not a bus at 2:00pm. There is an additional \$100 charge for Little Stars Extended Day, and a \$150 charge for Little Stars Extended Day Tennis.

The cost of transportation is \$160 per week, per camper. This price is non-negotiable. If you choose to send your camper on the bus for one-way transportation (ex. only on the way to camp, only on the way home from camp), or only for select days out of the camp week, we will accommodate, however we cannot prorate the cost of transportation.

Due to transportation enrollment running on a weekly basis, we cannot give an accurate estimate for pick-up or drop-off times until the bus routes have been assembled. The bus routes will be assembled once we have an accurate count for campers taking the bus during that week. If your camper is enrolled for camp and transportation for multiple weeks out of the summer, please do not assume that the pick-up time will be the same every week. Our office will alert parents the estimated pick-up and drop-off time by the Thursday before the start date of the camp week. So, if your camper is attending camp for the week of Monday, June 19, expect an email either on or before Thursday, June 15.

These terms and conditions are subject to change.

**Please note that we do not prorate camp tuition if your camper is not utilizing all five (5) days of the camp week. If you choose to send your camper to camp for a partial week, that is fine, but we cannot prorate camp tuition, nor the cost of transportation.*
